STUDENT'S REFUND POLICY

Students must notify the director in writing of their intention to withdraw from the program. A notice of cancellation shall be

in writing, and a withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance. This institution shall refund 100 percent of the amount paid for institutional charges, less application fee of \$75, if notice of cancellation is made through attendance at the first class session, or the seventh (7th) class day after enrollment, whichever is later. No refunds after 45 days of class start date.

NPTI has and maintains a policy for the refund of the unused portion of tuition, fees and other charges in the event the veteran or eligible person fails to enter the course or withdraws or is discontinued there at anytime prior to completion. The amount charged to the veteran or eligible person for tuition, fees and other charges does not exceed the approximate pro rate portions of the total charges for tuition, fees and other charges and that the length of the completed portion of the course should bear to its total length. The maximum non refunded registration fee is \$75.00. The remaining balance will be prorated accordingly. The institution shall pay or credit refunds within 45 days of a student's cancellation or withdrawal.

Refunds will be paid according to the following formula: *A non-refundable registration fee of \$75.00 is deducted from the total amount paid for the course. The remaining amount is then divided by the total number of hours in the course. This amount constitutes the "per hour" charge for the course. Finally, the number of incomplete hours in the course is multiplied by the "per hour" charge. The remaining amount is the refund that is owed to you.*
